

#### **REGULATION of Flutter Europe 2020 Conference**

## I. Flutter Europe 2020 Conference - Terms of Participation

Whenever the terms defined hereunder are used in this Flutter Europe 2020 Conference Terms of Participation, they should be understood as follows:

**Organizer** – LeanCode Sp. z o.o. based at: ul. Wróbla 8a, 02-736 Warsaw, entered to the Register of Entrepreneurs carried out by the District Court for Warsaw, XII Commercial Division of the National Court Register under the KRS number: 0000638275, NIP: 7010616433, REGON: 365456272.

**Conference Flutter Europe (Conference)**— an event carried out by the Organizer on the 23-24th of January 2020 in Warsaw, in Copernicus Science Centre venue, which is available to any person able to meet the conditions specified in this Terms of Participation.

**Fortuitous Events** – circumstances which despite maintaining due diligence are unpredictable and cannot be prevented or stood against effectively.

**Participant** – a natural person entitled to participate in the Conference by obtaining the Blind, Student, Early Bird, Regular, Late for party Tickets (hereinafter: Tickets).

**Application** – purchasing of a Ticket on the platform eventil.com.

**Regulations** – this set of regulations meaning the set of terms of participation in Flutter Europe 2020 Conference binding for all Participants.

**Regulations for the purchasing and usage of the Tickets** - terms of use of paid services offered as part of the Conference in the form of selected packages Blind, Student, Early Bird, Regular, Late for party.

**The right to information (information clause) -** information to which the Organizer, as Joint- controller of Participants' personal data, is required according to art. 13 § 1 and § 2 of the General Regulation on the Protection of Personal Data of 27 April 2016 (hereinafter: GPRD).



### § 1 TERMS OF PARTICIPATION

- 1. The condition for the participation in the Conference is purchasing a Ticket on the platform <a href="https://eventil.com">https://eventil.com</a>.
- Confirmation of making acquaintance to the Regulations constitutes the acceptance of this Terms of Participation, Code of Conduct and Privacy Policy which are available on the Conference website <a href="http://fluttereurope.dev">http://fluttereurope.dev</a> and the Participant's commitment to follow them.
- 3. Participation in the Conference constitutes a gratuitous, unlimited in time, in quantity and in territory, consent for gratuitous use, processing, replication and multiple dissemination of the Participant's image perpetuated on photos and videos made during Flutter Europe 2020 Conference for purposes of Conference communication, promotion and advertisement without the need of every-time consent. The above consent encompasses all forms of publication in particular dissemination in television, press and the Internet, including the Conference website under the address <a href="http://fluttereurope.dev">http://fluttereurope.dev</a>, open services, services with limited access, and social media portals like Facebook, Twitter, Instagram, YouTube and printed materials.
- 4. Persons under 15 years of age can participate in the Conference solely under the supervision of adults. The Organizer reserves the right to refuse an access for the Participants not meeting this requirement.

## § 2 RIGHTS AND OBLIGATIONS OF THE ORGANIZER

- 1. Organizer reserves the right to close the registration for the Conference or its particular parts (additional speeches, side events) as soon as the maximum number of Participants is reached.
- 3. Conference agenda will be published on the Conference website under the address: <a href="http://fluttereurope.dev">http://fluttereurope.dev</a> Organizer reserves the right to make changes in the Conference agenda. All changes will be announced on an ongoing basis under the same address. Such changes are not a basis for the reimbursement of charges in case of canceling the participation by a Participant.
- 4. In case of Fortuitous Events, the Organizer allows a possibility of changing the assumptions of Conference organization including the location and date. In such case, Organizer is obliged to inform the Participants about the changes via electronic mail sent to the address stated by the Purchaser in the Registration Form within 7 days.
- 5. Organizer is not responsible for lost or left behind by a Participant during the Conference.
- 6. Organizer has right to verify the identity of the Participant based on ID card with photo. The Participants are obligated to show their ID card at the Organizer's request.



# § 3 RIGHTS AND OBLIGATIONS OF A PARTICIPANT

- 1. Sound- and video-recording of the Conference, the venue and side events is prohibited without the written consent of Organizer.
- 2. Participants cannot address other Participants, speakers, and Organizer in a manner which violates their dignity or is contrary to general principles of social coexistence.
- 3. Participants are obliged to behave in a manner which does not disturb other Participants.
- 4. A participant shall bear full responsibility for any damages they made during the Conference on the venue or during the Conference side events.
- 5. Participants are obliged to execute all commands of security service employees or Organizer who hold adequate IDs.
- 6. Organizer reserves the right to remove a Participant from the Conference if they break the rules of this Regulations. In such case, no claims of his Participant are due, in particular, the claim of reimbursement of the Ticket cost.
- 7. Not using, not transferring or not picking up the Ticket is not a basis for the reimbursement of the Ticket cost.
- 8. Participants are obliged to wear in the ID issued by the Organizer a visible place during the whole Conference and show it on request of security service employees, information service employees or the Organizer. IDs will be checked at every entrance to the Conference venue and side events. Organizer reserves the right to remove any person without the ID, also subject to p. 6.
- 9. Organizer has right to put a conference band on the Participant's hand at the registration desk. Participants are obliged to wear a band on their wrist throughout the whole Conference and at all side events. A band which is not on the wrist, cut, broken or destroyed is invalid. In the case of accidental destruction of the wristband, the Participant is obliged to go to the appropriate services of the Organizer with destroyed band in order to register and receive a new band after confirming his rights. The bands will be checked during every entrance to venue areas or side events. Organizer reserves the right to prevent an access to selected areas and side events of a person who does not have conference band.
- 10. It is absolutely forbidden to enter and reside at the Conference under the influence of drugs or intoxicants or in a state of insobriety (amount of alcohol in blood exceeding 0,5 per mille or leading to exceeding this amount). The Participant undertakes to submit to a breathalyzer control by authorized entities.

# **ID Code of Participants**

1. Each Participant of the Conference from the moment of registration at the Conference has a unique identifier, where the Organizer places a unique ID code.



- 2. The ID code of the identifier is assigned to a specific Participant.
- 3. The ID code placed on the identifier shall in the first place ensure proper service to the Conference, in particular in the area of security and verification of Participants' entitlements.
- 4. The Participant is obliged to show the identifier and scan the ID code on every request of the Organizer's designated services. Failure to show the identifier or disagreement with the ID code scanning, entitles the Organizer to remove the Participant from the Conference area or additional events.
- 5. The Organizer shall make available only to the Conference Partners indicated on the website <a href="http://fluttereurope.dev">http://fluttereurope.dev</a>.
- 6. The Participant's ID code may be scanned by Partner only with the consent of the Participant whose identifier is being scanned.
- 7. The scanning of the ID code by the Partner means the possibility of transferring personal data of the Participant by the Organizer to the Partner and their processing by the Partner in order to contact the Participant after the Conference, in accordance with the Information Clause.
- 8. Scanning the ID code does not mean that the Participant's personal data is automatically transferred to the Partner. The scanning application does not collect personal data of Participants, as well personal data can't be downloaded from the Organizer's systems automatically.
- 9. The Organizer will provide personal data of the Participant to the Partner who has scanned the Participant's ID code, at Partner's request not later than within 30 days of the Conference closing date.
- 10. The Organizer inform that the Partner, to whom the Participant's personal data have been provided, in accordance with paragraph 9 above, should make the information obligatory to the Participant in accordance with applicable law.

#### §5 Withdrawal from a purchase contract distance Selling

- 1. The Participant who is a Consumer has the right to withdraw from the contract for the purchase of a Ticket without giving a reason within 14 days of making the payment as a completed purchase.
- 2. To comply with the deadline for withdrawal from the agreement, it is sufficient for the Consumer to send a statement before the expiry of that period to the e-mail address: tickets@fluttereurope.dev from the e-mail address used to purchase the Tickets.
- 3. In the case referred to in point 1, the Organizer upon receipt of a declaration of withdrawal from the contract for the purchase of a Ticket by a Participant, will block and then cancel the purchased Ticket in the sales system.
- 4. The Organizer will refund the price paid by the Participant for the purchase of the Ticket within 14 days from the date of withdrawal by the Participant to the bank account indicated by the Participant in the statement of withdrawal or in the absence of such data to the bank account from which the payment was made.



- 5. In the event that the date referred to in paragraph 1 shall expire on the day of the beginning of the Conference or later, the last day of withdrawal from the contract, shall be the day preceding the beginning of the Conference, which is 23th of January 2020.
- 6. On the day of the beginning of the Conference, due to the start of the service in accordance with the date indicated on the Ticket by the Organizer, withdrawal is no longer possible.

# §6 Change of Regulations

- 1. The Organizer is entitled to change the Flutter Europe 2020 Conference Regulations and this change becomes effective on the date indicated by the Organizer.
- 2. Information about the amendment of the Regulations is posted on the Conference website. If the changes are not accepted, the User should immediately notify the Organizer about the lack of acceptance of the changes to the address: <a href="mailto:contact@fluttereurope.dev">contact@fluttereurope.dev</a> in order to terminate the contract.
- 3. The Regulations are made available to the Users free of charge and continuously on the <a href="https://flutereurope.dev">https://flutereurope.dev</a> in a manner enabling the Users to obtain, reproduce, save its contents at any time.

#### II. Regulations for the purchase and usage of the Tickets

#### §1 Definitions

Whenever the terms defined hereunder are used in this Terms of Purchase and Usage of the Tickets, they should be understood as follows:

**Fortuitous Events** – circumstances which despite maintaining due diligence are unpredictable and cannot be prevented or stood against effectively.

**Participant** – a natural person entitled to participate in the Conference.

**Application** – purchasing of a Ticket on the platform eventil.com.



**Regulations** – this set of regulations meaning the set of Terms of participation in Flutter Europe 2020 Conference binding for all Participants.

**Ticket** – one of the following services: "Blind", "Student", "Early Bird", "Regular" or "Late for party".

**Purchaser** – a natural person, a legal entity, an organization unit without legal personality that purchased one or more Tickets.

# §2 Services purchase Blind, Student, Early Bird, Regular, Late for party

- 1. The conditions for purchasing a "Blind", a "Student", an "Early Bird", a "Regular", and "Late for the party" include applying for participation via the Application and making a relevant payment in accordance with the price list published on the Conference website.
- 2. Marking an option of "Blind", a "Student", an "Early Bird", a "Regular", or "Late for the party" in the Application and confirmation of acquaintance to the Regulations constitutes the acceptance of this Regulation set.
- 3. The Organizer selsl a limited amount of the services: "Blind", a "Student", an "Early Bird". a "Regular". and "Late for the party".
- 4. The Organizer has the right to refuse to sell the "Student Ticket" service and associated services in case of a purchase by a Participant who is not a Student. In such situation, the Organizer changes the order to the Late for the party Ticket and issue the summon to fill in extra charge. In case that the Participant doesn't fulfill this obligation, Organizer is no longer obliged allow the Participant to take part in the Conference.
- 5. In particular cases the Purchaser can use a discount price. The discount is admitted automatically by the registration system. The admitted discount relates to prices current at the moment of placing the order. Discounts do not add up.

# §3 Payment and inclusion into the list of Participants

- A Purchaser is entered into the list of Participants using one of the Ticket services after the payment reaches the bank account of the Organizer. The Purchaser will be immediately informed about this fact via electronic post sent to the address stated on the Registration Form.
- 2. In the case of canceling the Conference the money paid into the Organizers' bank account will be reimbursed not later than 14 working days from announcing the Conference cancellation onto the bank account from which the payment was performed.



- 3. Electronic payments service is provided by Payment Service Provider Stripe (hereinafter: Payment Service Provider).
- 4. The payment can be performed according to the Purchaser decision via a credit card.
- 5. In case of the need for a refund of a payment submitted via an electronic channel, it will be performed via the same payment channel.
- 6. In order to make a payment, it is necessary to express the relevant consents to the Payment Service Provider. The Organizer is not responsible for data processed by the Payment Service Provider.

#### §4 Service transfer

- 1. It is possible to transfer all services.
- 2. Organizer reserves the right to decline the transfer request.
- 3. The Participant who receives a service transfer is obliged to accept the Regulations on the website of the Conference <a href="https://fluttereurope.dev">https://fluttereurope.dev</a> and in the case of not accepting the Regulations on the site will be required to accept it during the registration process of attendance at the Conference and obliged to follow it. With regard to the processing of personal data, the Participant accepting the service transfer will receive an information clause regarding the processing of personal data for the purpose of providing the service after registering the attendance by sending it to the Participant's e-mail address.
- 4. All transfers must be completed by January the 15th 2020. The deadline may be changed by the Organizer.

# §5 Changing a Participant

1. Shall the Participant be unable to participate in the Conference due to reasons beyond they control the Organizer allows the possibility for another Participant designated by the Purchaser to participate in the Conference and use all the services purchased. This information must be sent via electronic mail to tickets@fluttereurope.dev no later than 5 working days before the Conference date. In case of failing to submit a change of the Participant, Purchaser will be charged with the full cost of all services purchased.

#### §6 Additional information

- 1. In case of Fortuitous Events, the Organizer reserves the right to change the principles of the Conference organization including the location and the date. In this situation, the Organizer is obliged to inform the Purchaser about the changes via electronic mail sent to the address stated on the Application. The Purchaser has a right to cancel their participation within 4 working days from the moment of receiving the information. The cancellation must be sent to the address tickets@fluttereurope.dev. The lack of cancellation constitutes the acceptance of changes introduced.
- 2. The benefits included in a payable service cannot be sold or shared with another



- Participant without the written consent of one of the Organizer.
- 3. The lunch included in the Tickets is served on Jan 23-24th between 12:00 and 15:00. The Participant is obliged to comply with the defined hours.
- 4. If a Participant does not use all the benefits or a part of the benefits included in their Tickets, no reimbursement applies.
- 5. The Purchaser and Participant/Participants shall bear the full, joint and severally responsibility for any damages made by Participants designated by them to use the Ticket services on the premises of the Conference venue and side events venues.
- 6. The Organizer does not bear responsibility for items lost or left behind by a Participant during the Conference or the side events.
- 7. Any possible disputes arising from contracts signed on the basis of this Terms of Participation Conference and Regulations for the purchase and usage of the Tickets will be settled by the court relevant for the headquarters of one of the Organizer.
- 8. The Purchaser agrees to receive invoices solely via electronic mail.
